Entries:

If you plan to enter after the closing deadline and/or day of, please email the trial secretary ahead of time as a courtesy.

Late and/or Day of Show entries are not guaranteed entry and will be accepted only up to judging limits. Confirmations may not be sent for late entries.

EXHIBITOR INFORMATION

All dogs must be kept on leash and under control while on trial grounds when not showing. Flexi leashes are not permitted indoors. Electronic, prong, and choke chain collars are not permitted by Happy Ratters, and are not permitted on show grounds by the host club.

Parking:

Please do not park in front of our neighbors' units. Overflow street parking is permitted, and exhibitors are also welcome to park in the bank's lot across the street if needed. There are handicapped parking spaces directly in front of the building with easy access.

Please pick up after your dog and dispose of waste in appropriate containers.

Food:

A cheese-themed potluck will be held in conjunction with this trial. Please consider bringing your favorite cheesy dish, or bring a side or snack that pairs nicely with cheese!

Trial Site:

This trial will be held INDOORS. The building is heated. Rings have slip-resistant rubber mats. We have indoor crating space available. Smoking and/or vaping are not allowed in the buildings or on the show grounds.

BIS:

Bitches in season are eligible for entry. They will be kept separate from all other dogs and will be run at the end of their class/trial. We will designate a BIS crating area.

If bringing a bitch in season, please inform the trial secretary prior to the trial when possible. Remember your dog must wear panties at all times at the show site (except when being taken out to potty.) Please come to the secretary's table before unloading your dog. Thank you!

Entry fees for bitches that come into season will be refunded until closing date of the trial if you wish to withdraw, although we encourage you to compete with your BIS.

REFUNDS:

No refunds will be issued after the entry deadline, except in cases of illness or injury with a note from a licensed veterinarian.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

AWARDS:

All qualifiers will be awarded a qualifying ribbon.

Placement ribbons will be awarded for 1st-4th place in each class.

Funny NO ribbons will be available for a small donation at a self-serve station (thanks for supporting our club!).

VOLUNTEERS:
