**Awards:**

Awards will be handed out at the conclusion of each trial. Ribbons are awarded for qualifying score and High in Class. New title ribbons will be awarded. \*Please let us know if you anticipate earning a larger title such as level 3 or above and what it is for.

**Venue:**

- The trial will be held at Zero BS Training Center. All dogs must be under control and on leash when not competing. **Please Do not let your dog potty in undesignated areas or on anything man-made. Please do not walk or allow dogs off leash on neighboring property as it does not belong to the venue host. Please clean up after yourself and your dog. Use the designated area to potty your dog.**
- Follow signs to parking.
- No camping or RV's on-site.

Hyde Park Dog Club reserves the right to remove any individual for any reason from the premises. No refunds will be issued.

**Notice to Exhibitors:**

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused, or barred from competition by the decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children, and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- Absolutely no alcohol or drug use allowed during the trials. If suspected, you will be asked to leave immediately with no refund and your entries will not be accepted at any future Hyde Parker Dog Club events.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- Bitches in Season may compete in the event. The Trial Secretary must be notified in advance, BIS will run last in their class, and panties must be worn when dog is outside of vehicle (except to potty). A potty area near the parking area will be designated for BIS.
- Move ups from Trial to Trial and Day to Day are allowed. A move up form must be completed for Day to Day

Move Ups. Judge & Trial Secretary must be notified in advance for Trial to Trial moveups.

- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$50 fee for any returned check or payment. Checks must be made payable to **Hyde Park Dog Sport. Email Entries Accepted. Please pay via check or secreterrier (\*\*Preferred method of payment and easiest): You can enter and Pay thru Secreterrier.com**

**Dog Registration:** Dogs must be registered with the North American Sport Dog Association before you enter a trial. NASDA registration is a one-time fee. You may register your dog online at <http://nasda.dog/registration>. You will receive their NASDA # which you will need to enter this trial.
