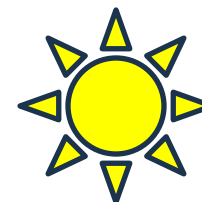
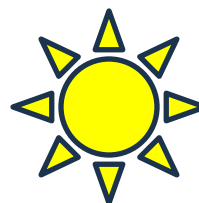
### From the West

### **Exhibitor Information:**

All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE PERMITTED FOR LINE DRIVE ONLY.** Please pick-up after your dog and dispose of waste in appropriate containers on the property.

 **Bitches in season are eligible for entry but will be required to wear panties, crate separate from all other dogs and will be run at the end of their class/trial.** If you are bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

### **Dog Aggression:**

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or the trial committee.

### **Animal Safety:**


The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and physically able to perform all course elements

 **The Dog Park and the Agility Course are for registered users only. Please do not enter these areas.**

 **Awards:** Brown flat ribbons will be awarded for all qualifiers in Crazy8, Line Drive, regular classes, and for the Instinct test. New title awards will be rosettes, new title awards for Crazy8s may be rosettes or medals, and large rosettes will be given to dogs who earn a RATCH. Judges choice awards, and other special sponsored ribbons may also be awarded.

### **Refunds:**


Refunds offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.


### **Cancellation Policy:**


Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.

### **Returned Checks:**

A returned check does not constitute a valid entry. There will be a \$50.00 fee for all returned checks.

 **Running Order:** Dogs will be run in random order with dogs being handled by the same person separated into different staged groups (Blinds).
