- Entries are limited to 8-hours of judging per day. If we fill, a wait list will be created, as needed
 - Pre-entry deadline is: 11:59pm on July 30, 2025. Entry fees for entries made after the deadline increase by \$5/trial. No mail-in entries available for this event.
- Cancellations must be made via email to the Trial Secretary
- No refund for cancellations after the closing date unless vacancies can be filled from the waitlist.
 - No refunds will be made for dogs that are absent, disqualified, excused, or barred from competition by a decision of the Trial Committee
- Exhibitors are responsible for complete, accurate and legible information on their entry forms
 - It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, weather, acts of God, public emergency, an act of a public enemy, or any cause beyond the control of Outland K9.
- All dogs must be on leash at all times except when competing
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid.
- Outland K9 reserves the right to refuse any entry without cause or explanation
 - Outland K9 reserves the right to remove any individual for any reason from the premises. No refunds will be issued
- Please pack food and water for you and your dog. There will be food available for a donation fee, but feel free to bring your own food.
 - Coolers with water and cooling pools with shade will also be available.
- No alcohol or drug use allowed during the trials, Outland K9 reserves the right to dismiss anyone suspected of alcohol or drug use from trial premises with no refunds.
