Awards: Ribbons are awarded for Qualifying score and High in Class. Rosettes will be offered for New Titles.

Notice to Exhibitors:

Bitches in season will run at the end of their class and must wear appropriate panties.

No refunds will be made for entries that are absent, disqualified, excused or barred from competition by decision of the Trial Committee.

Exhibitors are responsible for complete and accurate information on their entry forms. Be especially careful that your email address is clear.

Exhibitors are responsible for the behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children, and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.

All dogs must be on leash at all times except when competing.

Exhibitors are responsible for being in the staging area when it is their turn to run.

Please be courteous and pick up after your dog, this is a self cleaning venue.

All entries must be accompanied by entry fees to be valid. Entries are to be made online via Secreterrier. If you are unable to enter online, please contact D’Arcy Downs-Vollbracht to make other arrangements. Some limited day-of entries and add ons or move ups can be done day of in person.
